- Contractor shall meet all requirements of Driveway Ordinance #2251 and Tree Preservation Ordinance #2520
- Applicant acknowledges his liability for the work and related hazards
- Applicant shall provide a minimum of two (2) copies of the proposed construction plans with this permit form
- Proof of insurance, bond or other required financial information is current and on file
- Right-of-way user certifies that all work conducted under this permit complies with the NPDES storm water permit requirements and other provisions of the federal Clean Water Act
- Engineering plans drawn at a scale not to exceed one inch (1") equals one hundred feet (100') which show the proposed location(s) and route(s) of all facilities to be constructed or installed and the applicant's plan for right-of-way construction, including details of any bores, trenches, hand holes, manholes, switch gear, transformers, pedestals, etc. including depth
- Appropriate signage (i.e.: 3' X 3' Information Signs; "Utility Construction Ahead" or "Roadwork Ahead" signs)
- Show location of all right-of-way and easements to be used
- Show all existing city utilities in relationship to proposed work
- Detailed emergency procedures
- Detailed method of compaction, equipment must be on site
- Any deviation or exceptions to this permit must be approved by the City
