<b>Retaining Wall</b>
A permit is required for the installation of retaining walls four feet and above in height. This height is measured from the top of the wall to the bottom of the footing, whether exposed or covered. Such walls are required to be designed by a professional engineer. If a contractor is used, that contractor must be registered in the City of Carrollton. Retaining walls that face or have exposure to any public thoroughfare shall be constructed of brick or stone. An inspection will be required upon completion of work.
