<ol style="list-style-type: none"> 1. Must be a United States Citizen 2. Must be a registered voter on the date of election 3. Have not been determined by a final judgement of a court exercising probate jurisdiction to be totally mentally incapacitated, or partially mentally incapacitated without the right to vote 4. Have not been finally convicted of a felony from which the person has not been pardoned or otherwise released from the resulting disabilities 5. Must be 18 years or older 6. Qualified voter of the City of Carrollton 7. Must reside in the State of Texas for at least 1 year 8. Must reside in Carrollton, or in an area now within the corporate limits of Carrollton, for at least 12 months prior to the date of the election 9. Shall hold no other public office except that of a notary public or member of the National Guard or armed services 10. Not in arrears in payment of any taxes or other liability due to the City 11. Must satisfy any other eligibility requirements prescribed by Carrollton City Charter or Texas State Law 	<p style="text-align: center;">February 13, 2026 by 5:00 PM</p> <p style="text-align: center;"><i>The filing period begins on the 108th day prior to the election date and ends on the 78th day at 5 PM prior to the election date.</i></p>
